ADMISSION OF MINOR PARTICIPANTS

Maximum Martial Arts Academy staff member will allow only a parent, legal guardian or authorized adult to admit the Minor Participant in the care of Maximum Martial Arts Academy by signing the Minor Participant into the care of Maximum Martial Arts Academy. MEDICAL ATTENTION

The undersigned further agrees to make any and all arrangements for the Minor Participant's transportation and admittance to any hospital, health center or medical clinic in the event of any emergency situation involving the Minor Participant. In the event that parent(s) or emergency contacts are unavailable and it should become necessary, I authorize Maximum Martial Arts Academy to make decisions regarding any and all medical and survival procedures for the Minor Participants. ADMINISTRATION OF MEDICATION

There will be no administration of medication.

FEE POLICY

Full payment for the programs must accompany each Minor Participant's registration, unless you select the Payment Plan. The Payment Plan is available only for full week, full day reservations. A payment plan requires a deposit of \$100 for each week of registration. The monthly remaining balance is 2 weeks to the camp week. Failure to make a payment when due will result in Maximum Martial Arts Academy cancelling any applicable registration and any deposit(s) will be forfeited. Camp will not be offered on days declared to be national holidays and the fees for the programs shall include policy in its fee structure. Maximum Martial Arts Academy shall issue a refund for the dollar value of the missed session(s) within 30 days, for any session(s) cancelled by Maximum Martial Arts Academy due to bad weather or unforeseen circumstances.

CANCELLATION POLICY

Refund Policy. All cancellation requests must be made in writing. A \$100 non-refundable deposit will be required for all camps. The \$100 non-refundable deposit is included in the full week payment amount.

- **Payment Plan Refund Policy.** If a cancellation request is received more than 14 days before the first day of camp, I will receive a refund for the payment amount paid for each week of camp less the \$100 non-refundable deposit. If a cancellation request is received by Maximum Martial Arts Academy less than 14 days prior to the first day of camp, I will be responsible for all camp payments/fees. I understand that failure to make a payment on any due date (whether in person or rejected EFT draft) will cancel my participant's registration.
- **Paid in Full Refund Policy.** If a cancellation request is received 30 days or more before the first day of camp, I will receive a full refund of all camp fees paid, including the \$100 deposit. If a cancellation request is received 14 to 29 days prior to the first day of camp, I will receive a refund for the amount paid for each week of camp less the \$100 non-refundable deposit. If a cancellation request is received by Maximum Martial Arts Academy less than 14 days prior to the first day of camp, I will forfeit all fees for camp services.
- **T-shirts.** T-shirt fee must be paid with the deposit and is non-refundable.

LATE PICK-UP POLICY

Maximum Martial Arts Academy requires that a parent, legal guardian, or other authorized pick-up call 512-317-8989 if he or she knows or suspects that he or she will be late in picking up the Minor Participant. A Late Pick-Up fee will be charged in the amount of \$20.00 for the first 15 minutes that a parent, legal guardian, or other authorized pick-up is late and \$1.00 per minute thereafter. The Late Pick-up fee is payable upon the parent, legal guardian or other authorized pick-up's arrival or it will be due the following day with an additional \$5.00 late charge. If the Minor Participant is left for 2 hours past the pick-up time without a parent or legal guardian notifying the staff and the staff is unable to locate an emergency contact, the police will be notified. If the Minor Participant is left for 1 hour or more past the pickup time on 2 occasions without notifying Maximum Martial Arts Academy, the Minor will no longer be allowed to participate in the Summer Camp. Upon such event, no fees will be refunded by Maximum Martial Arts Academy.

FOOD POLICY

Maximum Martial Arts Academy will serve snacks and provide time for meals to Minor Participant in accordance with the following schedule: If Minor Participant has been in Maximum Martial Arts Academy's care for 7 to 10 hours, Maximum Martial Arts Academy will serve 1 snack and provide time for 1 meal and 1 other snack. All snacks provided by Maximum Martial Arts Academy will be within the guidelines of the Food Guide Pyramid, as developed and recommended by the U.S. Dept. of Agriculture. Any child with special dietary need to provide their own snacks. Minor Participant's parent or legal guardian is responsible for providing the meal or meals for Minor Participant while he or she is in Maximum Martial Arts Academy's care. No refrigeration will be provided for meals; please include only appropriate non-perishable food items. Each parent or legal guardian shall be responsible for ensuring that any such meals meet the dietary guidelines for Americans established by the U.S. Dept. of Agriculture. Please ensure that each meal is labeled with your child's name and date.

POLICIES, RULES AND REGULATIONS (PLEASE INITIAL)

_____ I understand and will comply with all rules and regulations for Summer Camp., which are subject to change at any time in Maximum Martial Arts Academy's discretion. I hereby agree that I, as well as the Minor Participant, will comply with all policies, rules, and regulations established for Summer Camp. Maximum Martial Arts Academy accepts registration on a space-available basis so early registration is recommended. Maximum Martial Arts Academy reserves the right to cancel Summer Camp with low enrollment. Make-up sessions are not given for any missed sessions. Maximum Martial Arts Academy reserves the right to remove the Minor Participant from Summer Camp and not allow the Minor Participant to register for any additional programs. Maximum Martial Arts Academy may remove any child for conduct that is deemed detrimental to the Summer Camp or Maximum Martial Arts Academy, including , but not limited to showing respect for others, treating equipment properly and obeying Staff Members. If Maximum Martial Arts Academy has reason to suspect that a child is abused or neglected, Maximum Martial Arts Academy may be required to report the matter immediately to the local department of the county or city where the child resides or where the abuse or neglected is believed to have occurred.

TRANSPORTATION OF MINOR PARTICIPANT

If the undersigned has enrolled Minor Participant in Summer Camp that involves field trips and transportation, the undersigned authorizes Minor Participant to participate in the Summer Camp field trips and authorizes Maximum Taekwondo and Yoga and its contractors to transport Minor Participation in a vehicle.

ASSUMPTION OF RISK, WAIVER, AND RELEASE OF LIABILITY AND INDEMNIFICATION

In consideration of the participation in Summer Camp, which includes Maximum Martial Arts Academy premises or participation in) Off-Premises Activities as defined below, by my Minor Participant, I hereby agree to all the terms and conditions in the Summer Camp registration, including specifically the **Assumption Of Risk, Waiver and Release of Liability, and Indemnification** provisions.

1. Assumption of Risk. I understand that there are inherent **risk of injury in the use of Maximum Martial Arts Academy's premises while participating in Maximum Martial Arts Academy's Summer Camp.** I also understand that there are risk of injury in the participation in the program that take place outside or off Maximum Martial Arts Academy's premises, including but not limited to field trips ("Participation in Off-Premises Activities") (**Collectively, "Risks"**).

I understand that such Risks include but are not limited to slip, falls, trips, collisions, overexertion, loss or theft of property (including from equipment failure or malfunction, drowning, or other accidents or incidents that may result in harm, loss, disability, death or other injury or damage to my Minor Participant.. I understand that such injuries may include , but are not limited to, minor or major personal, physical, bodily, emotional, mental, economic, property or other types of injuries or damages, including but not limited to scrapes, bruises, sprains, torn or damaged muscle or ligaments, broken bones, burns, respiratory or auditory problems, concussion, stroke, heart attacks or stress, lost wages, loss earning capacity, lost or stolen property, pain and suffering, disfigurement, paralysis, brain damage, or death. ("**Injury**" or "**Injuries**").

I understand that such injuries may be caused, in whole or in part, by the negligence of Maximum Martial Arts Academy (which includes its subsidiaries and employees), me, my Minor Participant, other participants in the Summer Camp and/or other members or guests.

I fully understand and appreciate, knowingly and voluntarily accept, specifically assume responsibility for, and freely choose to allow my Minor Participant to participate in Summer Camp which include the Use of Maximum Martial Arts Academy Premises or Participation in Off-Premises Activities in spite of, Risks of Injury set forth above.

2. Waiver and Release of Liability. On behalf of myself and my spouse/partner, children/Minor Participants, parents, guardians, heirs, next of kin, personal representatives, assigns and estate, I hereby voluntarily and forever release and discharge Maximum Martial Arts Academy from, covenant and agree not to sue Maximum Martial Arts Academy for, and waive any and all present and future claims, demands, actions, causes of actions, damages, losses or any other alleged liabilities or obligations, whether known or unknown ("Claims"), for any Injuries (which includes personal injuries and property damages) to me or my Minor Participant sustained in the Use of Maximum Martial Arts Academy Premises or Participation on Off-Premises Activities which arise out of, result from or are caused by, the negligence of Maximum Martial Arts Academy ("Waived Claims").

3. Indemnification and Legal Defense. I agree to defend, indemnify, protect and hold and save harmless Maximum Martial Arts Academy against any and all Waived Claims, including but not limited to those arising out of, resulting from or caused even in part by Maximum Martial Arts Academy's negligence, as well as any other Claims arising out of, resulting from, or caused by the use of Maximum Taekwondo Premises or Participation in Off-Premises Activities, by me or my Minor Participant.
